

## **DNC Puts Convicted Murderer On Virtual Convention Stage, Calls Her Community Leader**

Milwaukee, WI – The Democratic National Convention on Thursday night featured a “criminal justice activist” who was convicted of murdering a New York businessman found stuffed into a steamer trunk in Harlem.

Donna Hylton, who was known as inmate #86G0206 for 27 years at the Bedford Hills Correctional Facility, was given the platform at the Milwaukee convention on Aug. 21 despite the fact she is a convicted murderer, FOX News reported.

Hylton was asked to participate in the video reading of the Preamble to the Constitution by people whom the Democratic Party called “America’s most impactful community leaders,” according to a column in the Boston Herald.

This particular “impactful community leader” is a former prostitute who took part in the drugging, rape, torture, and murder of a 62-year-old gay New York businessman named Thomas Vigliarolo in Harlem when she was 19 years old.

A man named Louis Miranda hired Hylton and six of her friends to kidnap Vigliarolo, whom he said had stolen \$139,000 in a joint swindle they’d done together, FOX News reported.

The group of kidnappers consisted of four women and three men.

Prosecutors said Hylton and her cohorts took Vigliarolo prisoner and held him for 15 days, FOX News reported.

Hylton and her friends starved, burned, beat, sexually assaulted, and raped the businessman.

Prosecutors said Vigliarolo died of “asphyxiation and the deprivations of his imprisonment,” according to FOX News.

Hylton was caught by police after she delivered a ransom note and a witness captured a partial license plate number on her car.

Vigliarolo was later found dead, stuffed into a steamer trunk in Harlem.

She wasn’t actually present when Vigliarolo died, FOX News reported.

Hylton claimed at trial that Miranda had threatened to kill her four-year-old if she didn’t participate in the crime, but the jury didn’t believe her.

She was convicted of second-degree murder and two counts of first-degree kidnapping in 1985, and sentenced to 25 years in prison, FOX News reported.

The convicted murderer got her college degree in prison and then became a minister before she was paroled in 2011.

After she got out of prison, Hylton wrote a book about her life and became an outspoken advocate for prison reform, FOX News reported.

“So incredibly honored and humble to have been asked to participate in the Preamble of the Constitution for the DNC tonight. With deep thought, I accepted this opportunity to represent the millions of Americans who have been left out and shut out,” Hylton tweeted late on Thursday night.

Social media exploded with Americans wanting to know why the DNC was rallying behind a convicted rapist and murderer.

It comes as no surprise that the Democrats chose to showcase a criminal, considering they also chose to ignore the crime raging across the country in the form of “Black Lives Matter” and “Antifa” riots.

Each of the four nights of the Democratic National Convention (DNC) was dominated by gloomy messages of racial division, victimhood, and disdain for President Trump, despite the party’s official theme of “Uniting America.”

The Democrat Mayor of DC, Muriel Baston, lead off her speech by saying:

“Our nation is facing a lot right now and over the next four nights we are going to cover it all.

But tonight we are going to talk about three specific crises we face the pandemic, an economic downturn, and an ongoing systemic racial injustice.

“But we’re not just going to focus on what’s wrong; we’re going to talk about how to make it right.

“When peaceful protestors were tear-gassed across from the White House our next speaker stood up, stood strong, and turned that place into the Black Lives Matter plaza in their honor.”

Of course, there are many issues with her opening remarks, but, for the moment, let us just focus on the one glaring lie that she said:

“When peaceful protestors were tear-gassed across from the White House.”

In an interview with CBS in June, Attorney General William Barr was asked a question regarding the so-called peaceful protests that Baston spoke about in her opening remarks.

Barr said:

“There were three warnings given. But let’s get back to why we took that action. On Friday, Saturday and Sunday, OK, there were violent riots in- at Lafayette Park where the park police were under constant attack at the- behind their bike rack fences. On Sunday, things reached a crescendo.

“The officers were pummeled with bricks. Crowbars were used to pry up the pavers at the park and they were hurled at police. There were fires set in not only St. John’s Church, but a historic building at Lafayette was burned down.”

Now that this lie is settled, we can focus on other falsehoods presented by the democratic leaders in their speeches. For instance, the lie in which the democrats claim President Trump spoke about white supremacists at the riots in Charlottesville, Virginia in 2017 as being “very fine people.”

What was really said by President Trump was this while speaking with reporters, courtesy of network news:

“Excuse me, they didn’t put themselves down as neo-Nazis, and you had some very bad people in that group. But you also had people that were very fine people on both sides...You had people in that group that were there to protest the taking down, of to them, a very, very important statue and the renaming of a park from Robert E Lee to another name.”

President Trump than made his stance clear:

“I’m not talking about the neo-Nazis and the white nationalists, because they should be condemned totally – but you had may people in that group other than neo-Nazis and white nationalists, okay?

Now, in the other group also, you had some fine people, but you also had troublemakers [Antifa] and you see them come with the black outfits and with the helmets and with the baseball bats – you had a lot of bad people in the other group too.”

Now that that is settled, we can look at what else the democrats also spewed. Democratic leaders spoke against President Trump’s sending of additional federal police to protect federal buildings in Portland.

They claimed, falsely, that the unrest occurring in Portland was directly a result of the federal authorities being there. However, this could not

have been the case as riots were occurring both well before the increased federal presence, and after.
