At 5:40 A. M., Monday morning of June 3, 1974, our pastor's son, James Hughes gave his life in service as he served our state as a state trooper. James had stopped his patrol car to give assistance to two ladies stranded beside the road. As he stood by the parked car a truck veared off the road way and collided with the parked vehicles and took the life of this young man.

Our church mourns the loss of this son. Our hearts go out to our pastor and his family. We do not have words to express the loss that we feel for this family, our church, and to the community.

A memorial service will be held in our church at 4:00 P. M. on Wednesday, June 5. Dr. William L. Lumpkin, Pastor, Freemason Street Baptist Church, Norfolk, Virginia, will hold the service.
